RESOLUTION OF THE TOWNSHIP OF STAFFORD, COUNTY OF OCEAN, APPOINTING MEMBERS TO THE EMERGENCY MANAGEMENT COUNCIL

WHEREAS, it is the desire of the Mayor and Township Council to reappoint these qualified individuals to the Emergency Management Council; and
