

### DETAILS:

According to the Attorney General's Guidelines on Internal Affairs Policy and Procedures "each agency must annually release reports to the public summarizing allegations received and investigations concluded for that period... In addition, each agency shall periodically release a brief synopsis of all complaints where a fine or suspension of 10 days or more was assessed to an agency member..."

The Attorney General has requested that Internal Affairs summary reports be posted on agency web sites throughout the state. As such, when all 2016 IA annual summary reports are completed and forwarded to the OCPO each agency's report will be posted on the OCPO web site under "Internal Affairs" along with the IA annual summary report for OCPO which has been posted on the OCPO web site since 2014. Each agency should consider posting their own IA summary report(s) on their web site for public access in order to comply with the AG Guideline or at a minimum post a link to the OCPO web site where the IA summary reports can be located.
